## **Guidelines for Booking Grip Van:**

- 1) Drivers are required to possess a valid driving licence of <u>2 years and above.</u>
- 2) Drivers must be the age of at least 22 years old.
- 3) Drivers (and guarantors if applicable) must bring along their NRIC and valid driving licence during collection of the rental vehicle.
- 4) If more than 1 driver is expected, provide the details of all possible drivers during booking/collection.
- 5) A cash deposit of \$200 is required upfront upon the collection of the Vehicle, refundable upon the return of the Vehicle and the equipment in their original order. A clean up fee of \$50 applies if the equipment is not put back into the original layout arrangement and/or the interior condition of the van is found to be less than ideal.
- 6) Customers will be <u>fully responsible</u> for any damages to equipment and vehicle including 3<sup>rd</sup> party claims.
